**LEFT OR DRIVER'S SIDE** 

**RIGHT OR PASSENGER'S SIDE** 

TO EASE INSTALLATION OF YOUR FRONT FLOOR LINERS, MOVE THE FRONT SEATS TO THEIR REAR MOST POSITION. WITH THIS DONE, REMOVE THE FACTORY CARPET HOOKS. REMOVING THE HOOKS WILL ALLOW YOUR LINER TO LAY COMPLETELY FLAT. TO REMOVE THE HOOKS, APPLY FIRM AND EVEN PRESSURE WHILE LIFTING THE END OF THE HOOK STRAIGHT UP. WITH THE HOOKS REMOVED, INSTALL THE LINERS AND REPOSITION SEATS AS DESIRED. SAVE THE HOOKS AND REINSTALL THEM SHOULD YOU REMOVE THE LINERS.

AS IT IS BOXED, YOUR DRIVER'S SIDE LINER COVERS THE FUEL DOOR RELEASE LEVER. TO ACCESS THE RELEASE LEVER YOU CAN SIMPLY JUST LIFT UP THE LINER, OR, YOU CAN TRIM AWAY THE LOWERED AREA ON THE LINER LOCATED DIRECTLY ABOVE THE RELEASE LEVER. TO TRIM, USE THE EDGES OF THE RECESSED AREA AS A GUIDE. THE DIAGRAM ABOVE SHOWS THE AREA DARKENED.

**NOTE TO COROLLA OWNERS**: IF YOUR COROLLA DOES NOT HAVE THE FACTORY "ALL-WEATHER GUARD PACKAGE", THE LINERS WILL NOT FIT YOUR VEHICLE CORRECTLY. THE ALL-WEATHER PACKAGE INCLUDES DUCT WORK THAT RUNS UNDER THE FRONT CARPET. PLEASE SEE THE NEXT PAGE FOR MORE INFORMATION.

## INSTALLATION INSTRUCTIONS FOR YOUR TOYOTA COROLLA / MATRIX & PONTIAC VIBEREAR SEAT WeatherBeater® FLOOR LINERS

FRONT OF VEHICLE



TO EASE INSTALLATION OF YOUR COROLLA / MATRIX / VIBE SECOND SEAT LINER, MOVE THE FRONT SEATS TO THEIR MOST FORWARD POSITION. WITH THIS DONE, INSTALL LINER IN VEHICLE. ONCE LINER IS IN PLACE, REPOSITION THE FRONT SEATS AS NEEDED.

THE FACTORY "ALL-WEATHER GUARD PACKAGE" INCLUDES DUCT WORK UNDER THE FRONT ROW CARPET THAT ALLOWS AIR TO BE DIRECTED TO THE SECOND ROW SEATING AREAS. THE ADDITION OF THE DUCT WORK ADDS RAISED AREAS IN THE CARPET THAT OUR FLOOR LINERS (#9853) ACCOMMODATE (SEE CIRCLED AREAS BELOW). IF YOUR VEHICLE DOES NOT HAVE THIS DUCT WORK, THE FLOOR PANS ARE FLAT AND IN THE CIRCLED AREAS AND PART #9853 WILL NOT FIT CORRECTLY.
